SECTION-II

INSTRUCTIONS TO BIDDERS

1) Scope

- Interested bidders fulfilling the eligibility criteria may submit their bid.
- The services will be provided DHH to SC HWC level in the district.
- General Pests/Insects Control- Pest and Animal Control Services involve spraying the entire premises and surrounding areas with special reference to Bathroom, Kitchen, Pantries, Drainage, Sewers, Toilets and other vulnerable areas such as lift lobbies, main entrance, dispersal area etc. This service will cover Pests like Cockroaches, Bedbugs, Silverfish and certain extent of flies and Mosquitoes.
- Rodent Control- Pest and Animal Control Service meant for controlling rat problem inside as well as outside the premises and safeguarding the important files, papers, boxes, carpets, electrical and telephone wiring, wooden ceiling, paneling, cardboard, raw materials, etc. from rodent's damage.
- Termite Control- Termites are a group of insects that mostly feed on dead plant materials, with the ability to digest cellulose. Injecting termiticide into affected portions of the woodwork, woodwork in contact with machinery for example, door frames, cabinets, cupboards etc. shall be treated by drilling and injecting termiticide at the points of contract. Through drilling holes at the junctions of the walls and the door and pumping chemicals through these holes, wherever necessary. The drilled holes are effectively sealed thereafter. The application of blanket spray and dusting wherever necessary.
- Pigeon & Birds' Control- Pest and Animal Services prevent pigeon and bird's entry in the premises with the use of bird spikes and Anti Bird net.
- Snake Control- Snake Control is done by using a non-lethal chemical which acts as a repellent when applied on surfaces and the periphery of structures, creating a barrier to entry.
- The pesticides, etc. used for pest/rodent control should not create adverse impact on human health.
- The staff deployed by the agency, should be trained in pest control work, should be of good conduct, should be physically fit for the work and should not be suffering from any chronic or contagious diseases for carrying out the maintenance works. ZSS, Sundargarh shall not provide any personnel for the work.
- None of the deployed staff should enter or remain in the health facility's premise beyond the specified time limits unless and absolutely necessary.
- Authorized persons of health facility shall monitor the work of the agency or at regular intervals.
- A forwarding letter with attachment of bill vouchers, work execution certification, service challan for pest control services is to be submitted to district after completing the month for payment of the service.

- The agency shall bear all taxes, rates, charges, levies or claims, whatsoever, as may be imposed by the State/Central Government or any local body or authority. The agency shall furnish such proof of payment of compliance or the obligation including registration certificates, receipts licenses, clearance certificates etc.
- The agency shall be solely responsible for compliance of all statutory provision like payment of minimum wages to the personnel deployed, ESI, Insurance, PF, etc. ZSS, Sundargarh shall have no liability in this regard. Any revisions or amendments made to these laws/Acts by the State/Central Government will be automatically applicable for compliance by the Principal Employer and the Service Provider without any separate sanction for the same.
- The agency is responsible for compliance to the provision of various labour and industrial laws relating to the personnel deployed by it for the purpose or any accident caused to them and ZSS Sundargarh shall not be liable to bear any expenses in this regard.
- ZSS Sundargarh shall not be held responsible for any statutory non-compliance on the part of the agency with respect to the Labour Laws including PF, ESI, Workman Compensation, Insurance, Minimum Wages Act, Labour Safety, etc. or otherwise. And in no circumstances, the ZSS Sundargarh shall be made a party to it in case of any dispute arising out of such non-compliance.
- Income Tax/GST as applicable, shall be deducted by ZSS Sundargarh from the bill unless exempted by the Income tax Department.
- Any non-performance, damage/theft caused by the workmen of the service provider shall be recovered from the submitted bills of the service provider.
- If the successful bidder fails to execute the order, the performance security will be forfeited and action will be taken to blacklist the firm.
- If the successful bidder fails to execute the given order during the tenure, the L2 will be given chance to carry out the same activity till over of the tenure with same price quoted by L1 , if agree by the L2 agency.
- Termination of Contract: The agreement shall be come to an end either on completion of the contract period or shall be terminated for the following reasons:
 - A. Mutual consent: The contract may be terminated based on mutual consent in case the service are no longer required. Termination based on mutual consent will not attract any penalties or shall not be liable for any extra payments other than payment of invoices raised till the time or termination including notice period.
 - B. Breach of contractual obligations: Any incidents considered as the breach of contract will result in immediate termination of services. The buyer shall have the right to terminate the contract
