Applications are invited from the eligible candidates to be engaged purely on contractual consolidated remuneration on the basis of the following different posts lying vacant in Place of safety, Rourkela.

The Interested candidate shall submit the offline application form, duly filed by the candidate along with self-attested photocopies of the certificates and marksheets of academic background and experiences, and recent passport size photograph(self-attested) to **The Superintendent, Place of safety, Near Special Jail, at Jail Road, Pin-769004** via Speed Post/ Registered Post only sharply before 5 PM within 25 days of the publication of this advertisement.

The candidates must fill the online form through the link <https://forms.gle/1HGjafPopW2TQeBS8>. The required age of the candidate as on the first day of the year of the publication of recruitment notice shall be with limit to lower age:21 years, and upper age: 45 years.

The candidates are required to mention the category of the post applied for and it must be legible in CAPITAL LETTERS on the top of their respective applications. **The candidates are required to submit separate application for each post under each category, if the candidate prefers to apply for more than one post.** Each such application must be accompanied with the required documents. Incomplete, faulty applications or application received after due date shall be rejected.

The posts are purely scheme based consolidated contractual and temporary in nature. Period of engagement may be extended for the further period, based upon satisfactory performance. These are not the permanent posts and permanent job cannot be claimed.

3. CERTIFICATES / DOCUMENTS TO BE ATTACHED WITH THE APPLICATION FORM: -

- a) Self-attested Photocopy of HSC, +2, Graduation, Post graduation or any other professional qualification certificate and mark sheet.
- b) One recent self-attested colour photograph should be affixed to the application form.
- c) Certificate of experience issued from previous employer, as applicable for the post.
- d) No Objection Certificate from the employer.
- e) Self-declaration regarding non-involvement in any criminal activities especially child related offences.

4. OTHER ELIGIBILITY CONDITIONS: -

- a) The candidate must be a citizen of India.
- b) He/ She must be good character and of sound health and free from any organic defect and physical infirmity.
- c) He/ She must be able to speak, read, and write odia fluently and must have passed an examination in odia language equivalent to that of middle school standard.

5. GROUNDS OF REJECTION OF APPLICATION: -

Applications of candidates will be rejected by the selection committee on any of the following grounds:

- g) Not signing declaration (Full signature) in the application form.
- h) Not coming within the age limit as mentioned in para 2 of advertisement.
- i) Not having requisite qualification as provided under para – 1 of advertisement.
- j) Not submitted No Objection Certificate from the employer.
- k) Submission of wrong information/ false information about qualification/age etc.
- l) Any other ground as per the decision of the selection committee.
