TERMS AND CONDITIONS

- Sundargarh municipality, Sundargarh invites bid from interested/ intending eligible bidders who meet the eligibility criteria for selection of advertising agency at the specified places inside Sundargarh municipality area. The revenue generated through advertising will go to the advertisement firm and the advertisement firm would have to pay a fixed amount to Sundargarh municipality in the form of an authorization fees for the use of the advertising space. The fee as agreed is to be paid to Sundargarh municipality independent of the quantum of the revenue generated by the advertising firm through the commercial use of the space.
- 2 The details of bid documents specification, schedule and set of terms & conditions is available in the municipality office, Sundargarh in person on payment of **₹4,000.00** (Rupees:- Four thousand) Only towards cost of Eol documents in shape of Cash/ DD/ Banker cheque drawn on any Nationalized Bank in favour of Executive Officer, Sundargarh municipality payable at Sundargarh. The Eol will be available in the Sundargarh district portal i.e. Sundergarh.odisha.gov.in. Paper cost shall be paid as per the same method noted in DTCN downloaded online. Eol without payment of paper cost shall not be accepted in any case and will be rejected summarily. The cost of quotation/ Eol paper is not refundable.
 - 3 The bidder must be accompanied by EMD/ bid security in original amount of **₹20,000.00** (Rupees:- Twenty thousand) Only in shape of Cash/ DD/ Banker cheque/ National savings certificate/ Post office savings Bank account/ Post office Time Deposit/ Kissan Vikas Patra / Deposit Receipt of Schedule Bank drawn on any Nationalized Bank in favour of Executive Officer, Sundargarh municipality payable at Sundargarh. Expression of Interest without EMD in original shall not be accepted.
 - 4 The sale of Expression of Interest (Eol) documents start from **dt. 10.09.2024 to dt. 21.09.2024**. Request for Expression of Interest (Eol) documents through post will not be entertained.
 - 5 **Offline** bid documents consisting of technical & price bid shall be provided within a single envelope superscripted with name of work, Expression of interest call notice no & date. Submission of bids will be through the offline mode to the given address of authority.
 - 6 The completed & sealed Expression of Interest (Eol) should be sent on or before **dt. 23.09.2024 upto 1.30 PM** to the Executive Officer, Sundargarh municipality through registered/ speed post or in person only. The envelope containing the quotation/Eol documents should be superscripted with "Selection of advertising agency for allotment of advertisement space rights in Sundargarh municipality area." with Eol call notice no & date.
 - 7 The Expression of Interest (Eol)/ bid documents will be opened in the presence of tender committee of Sundargarh municipality on **dt. 23.09.2024 at 4.30 PM** in the chamber of Executive Officer, Sundargarh municipality, Sundargarh in the presence of the bidders or their authorized representatives who wish to attend. If office happens to be closed for any reason on the date the receiving or opening of the tender as specified the tenders will be received/ opened in the next working day at the same time & venue.
 - 8 No bids will be received after scheduled date and time. The officer inviting the bid shall not be responsible for any postal delay and/ or non-receipt due to any frivolous reasons.
 - 9 Bidder should submit (i) Technical bid is to contain of cost of bid document and EMD in original, self attested copies of valid registration/ MSME certificate, up-to-date GSTIN, No Relationship Certificate, litigation certificate, filled up and signed with seal of schedule appended to the Eol call notice and documents required as per DTCN.
(ii) Financial/ Price bid/ BoQ is to contain the price bid duly filled and signed by the bidder.
 - 10 Bidder should carefully examine and analyze the quotation and to carry out its own investigation with respect to all matter related to the quotation, seek professional advice on technical, financial, legal and regulatory and taxation matters and satisfy itself of consequences of entering into any agreement and/ or arrangement relation to the quotation.
 - 11 The Quotationer should quote single rate for each item according to required specification wherever mentioned. More than one rate for a particular item will be summarily rejected.
 - 12 **The bidder shall quote their rate including cost of fitting, fixing, erection, all materials, labour, T&P, transporting, loading & unloading etc as per description in BoQ/ specification.**
 - 13 The rate shall be quoted inclusive of all taxes and duties if any.
 - 14 Any correction or over writing in the offer should be attested by the quotationer.
 - 15 The rate should be mentioned in both figures and words.

- The approximate of estimated area is 9000 sqft hoarding and 3000 sqft kiosk. Beyond above area the bidder shall pay extra amount as fixed by Municipal council, Sundargarh.
- The Offset price for the work is ₹ 6,50,000.00 (Rupees:- Six lakhs fifty thousand) only. The rate quoted below offset price is liable for rejection of tender and forfeited of EMD.
- 18 The Sundargarh municipality, Sundargarh will award the contract to the successful bidder whose quotation will be determined to be substantially responsive and who will offer the highest quoted price.
- 19 Executive Officer, Sundargarh municipality, Sundargarh will sign an agreement with the successful bidder for a period of 1 (one) year. This may be extended maximum up to 03 years with enhancement of 10% of the bid value for subsequent financial year subjected to satisfactory performance rendered by the service provider.
- 20 The bidder shall submit the quotation/ expression of interest schedule duly signed by him with seal.
- 21 The materials/ parts will be inspected by the Executive Officer/ Engineering person of Sundargarh municipality/ or any competent authority authorised by municipality.
- 22 Any material/ parts found defective are to be replaced immediately free of cost.
- 23 The quotationer/ bidder shall not sublet, transfer or assign any part of the full work of this award without prior written permission from the Executive Office, Sundargarh municipality.
- 24 All bids received will remain valid for a period of 90 days. The deadline date for submission of bids and validity of bids can also be extended, if agreed to by the bidder and the Department.
- 25 By written notice of the Executive Officer, Sundargarh Municipality should suspend the agreement if the bidder fails to perform any of his obligations as per the terms and condition of the contract/ agreement including accruing out the services, such notice of suspension shall:
- A specify the nature of failure.
 - Executive Officer, Sundargarh Municipality, Sundargarh may terminate the contract by not less than 30 days written notice of termination to the successful bidder on occurrence of any of the events specified below and / or as specified in the terms and conditions/ agreement. The decision of the Executive Officer Sundargarh Municipality shall be final and binding on the supplier/ service provider.
 - If the bidder becomes insolvent or bankrupt.
 - If a result of force majeure, the bidder unable to perform a material portion of the service for a period of not less than 30 days.
 - If the service provider/ supplier is found to be engaged in corrupt or fraudulent practices in competing for or in implementation of the project.
- 26 The EMD shall be forfeited on the following grounds :
- If the bidder withdraws the bid after bid opening during the period of bid validity.
 - If the bidder does not accept the correction of the bid price.
 - In the case of a successful bidder fails to sign the agreement/ contract or deposit the tender amount within the specified time limit .
 - In case the statements, documents and certificates submitted during submission of bid by the bidder is found false/ fabricated/ bogus,
 - If the successful bidder fails to execution of work within the period mentioned in the work order.
 - If the bidder does not replace any defects in the product/ work within days of being informed about the same.
- 27 Quotation/ Expression of Interest (Eoi) shall not be considered through Power of Attorney
- 28 Government advertisement policy should be followed during execution.
- 29 Government and Official hoarding should be displayed as and when required in free of cost.
- 30 Award of contract will be issued by post/ hand/ email.
- 31 Any dispute arises between bidder & office, the decision of the Council will be final and binding to both parties.
