- ❖ Manufacturer should have Local service support.
- ❖ Manufacturer should have ISO 13485.
- ❖ The OEM should not be banned/debarred/blacklisted by any government/ institution globally. The OEM must submit the self-declaration regarding the same.
- ❖ Bidder will have to submit OEM Authorization on OEM letterhead with bid number for Quoted Product.

DISPOSABLE CUSCO SPECULUM

1. USE:

- Device for temporary use as a help for the vaginal inspections for the dilatation of the vaginal canal and the exposition of the uterine neck during gynecological visits.

2. DESCRIPTION:

- The speculum has been manufactured with a fully anatomic contour.
- The central pin speculum allows to block the speculum at the required opening.
- For dilation of the vaginal canal to expose the uterus neck. It allows the adjustment of the vaginal opening by positioning the blades and locking the central key. The smooth surface and rounded edges aid a comfortable introduction. The central key can be bent down for an easier introduction of cumbersome instruments
- It is transparent and by a light source it allows to check the internal vaginal walls.
- The advantage of disposable products is due to the fact that surgeries usually do not have autoclaves.
- The physician's professionalism is improved when using disposable and sterile articles.
- The Export Spec opening is of 45°.
- The opening section, from where the visit takes place (observation section turned towards outside) is of approx. 1200 sq.mm.

3. FEATURES

- The disposable vaginal speculum is manufactured with transparent, material.
- **PHTALATES:** the raw material of the devices is phthalate-free
