



1. The envelope should be superscribed with "QUOTATION CALL NOTICE FOR SUPPLY OF DIGITAL X-RAY FILM (MODEL: DRIPRO SIGMA) TO CENTRAL STORE, GMCH, SUNDARGARH".
2. Copy of GST registration certificate, PAN No., ISO Certificate etc. should be attached with the quotations.
3. Copy of valid authorized supplier certificate for supply of that items should be attached with the quotations.
4. All the documents shall be serially numbered and self-attested by the bidder.
5. For any Postal/ Courier delay the undersigned will not be held responsible.
6. The supply should be made in good packaging condition & labelling.
7. The goods should be supplied to the destination and no charge for freight should be claimed.
8. The quotation received after due date & time fixed will not be entertained.
9. Price quoted should not be more than the open market price. An undertaking in this regard to be attached.
