The Project Administrator, ITDA, Panposh on behalf of Governor of Odisha invites Percentage Rate bids in **Double Cover System** only in ON LINE mode for the works as detailed in the table from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways or in equivalent rank may participate in the tender but the bidder has to register under the State PWD before signing of the agreement. **The bid will contain 2nos. (double) cover. First cover will contain VAT, PAN, GST, No Relation Certificate, Work experience, Machinery, Electrical MoU and Affidavit (As per Annexure) and the 2nd. cover will contain the BOQ only.** The proof of registration from the appropriate authority shall be enclosed along with the bid documents.

The Bidder shall make electronic payment using his/her Internet banking enabled account with designated Banks/ branches or their subsidiary Banks such as SBI/ICICI/HDFC or the bidder having account in other scheduled bank can make payment using NEFT/RTGS facilities of designated Banks as per W.D O.M No. 6785/9.5.17 read with WD. OM No. 17254/05.12.17. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender as Bid security. 6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.



7. Bids shall be received only through "On-line" on or before 5.00 PM of 19.11.2024.
8. Bids received "on-line" shall be opened at 11.00am on 20.11.2024 in the office of the PA ITDA Panposh in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue
9. **Bid Security Declaration (EMD):** Amount noted against the work as per Annexure (Col.6) to be paid online as per office Memorandum No. 6785 dt. 09.05.2017 of works Deptt. Govt of Odisha.
- 10 Cost of Tender Paper: As per Col-7 of Annexure attached (Non-refundable) only to be paid online as per office Memorandum No. 6785 dt. 09.05.2017 of works Deptt, Govt. of Odisha.
- 11 Mode of Submission of tender: Tender should be submitted online www.tendersorissa.gov.in.
- 12 Bid documents consisting of qualification information and eligibility criteria of bidders, plans, specifications and schedule of quantities of the work is available in website [http:// www. tendersorissa.gov.in](http://www.tendersorissa.gov.in) and the set of terms and conditions of contract and other necessary Documents can be seen in the web-site till last date and time of on line bidding. The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid /tender the said period or makes any modification in the terms and condition of the bid, the said earnest money shall stand forfeited.
- 13 Any tenderer desirous to avail any facility as per certain circular/ order of Government have to apply for the same in Affidavit. Claim at the time of opening of tender or later will not be entertained.
- 14 If the rate quoted by any bidder is less by 15% or more than the estimated cost put to tender than such bid(s) shall be rejected.
- 15 A bidder shall not be permitted to bid for works in the ITDA, Panposh, she/he shall be held responsible for the award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted in this deptt or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive).
- 16 No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Govt. permission.
- 17 **Additional performance security (APS) (As per works deptt. O.M, No. 4559/dt. 05.04.2021) shall be obtained from the bidder when the bid amount is less than estimated cost put to the tender. In such an even only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional performance Security as per the following rate:**

The applicable Additional performance Security (APS) shall have to be furnished by the successful bidder in shape of inscope of TDR/NSC/KVP/TD etc. duly pledged in favour of P.A, ITDA, Panposh within 7days of issue of Letter of Acceptance (LOA) by the P.A, ITDA, Panposh, failing which the bid shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder.

- 18 Bid submission:- Only after receipt of intimation at the e-Tender portal regarding successful transaction by bidder the system will activate the "Freeze Bid Submission" button to conclude the bid submission process.
- 19 Authority will not be held responsible for system failure, malfunction of internet or network traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
- 20 In the event of the specified date of bid opening being declared as a holiday, the bids will be opened at the Appointed time on the next working day.
- 21 The codal provision for e-Procurement will be followed as per Memorandum No.7885 Dated. 23.07.2013 duly amended vide Office Memorandum No.11774/W dated.03.08.2017 of Works Department, Govt. of Odisha and it is applicable for all bidders.

 5. List of Plant and Equipment to be deployed on the contract work (vouchers-owner/ affidavit) in Schedule- E (applicable for the work- 1 & 2 only).
 6. EMD, see Sl.No.-9 in Terms & Condition.
 7. The Valid License certificate, PAN card and GST certificate.
 8. 50% of the turn over certificate of amount put to tender.

- 23 The Corrigendum/ Addendum (if any) will be hosted in the web site www.tendersorissa.gov.in only.
- 24 Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in.
- 25 The Amount put to tender is exclusive of GST. The intending Bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of Bill.
- 26 All bidders are advised to go through the Office Memorandum No.6785 Dt.09.05.2017 of Works Department, Govt. of Odisha for electronic receipt, accounting and reporting of cost of tender paper.


