A walk-in-interview is scheduled to be held on 10-01-2025 at EMRS, Lathikata (EMRS Laing Campus) under Sundargarh District for selection of candidates to be engaged as guest faculties for the subjects as mentioned below.

The walk-in-interview will commence from 10:00 AM onwards and the registration of the candidates will start an hour before the commencement of the interview. The interested candidates fulfilling the eligibility criteria as mentioned above may attend the walk-in-interview in the office of the Principal, EMRS, Lathikata (EMRS Laing Campus) on the above-mentioned date and time along with their CV and the certificates of educational qualification.

**Mode of selection:** - The marks will be assigned to the candidates in the following manner and on the basis of the marks secured by the candidates the merit list will be prepared:

**Honorarium:** -The guest faculties will be paid consolidated honorarium as mentioned below:

1. TGT – Rs. 22000/- per month.
2. PGT – Rs. 25000/- per month.

**Duties and responsibilities:** -The candidates who would be selected as guest faculties shall perform the following duties and responsibilities:

- a. Teaching of concerned subject as per CBSE Standard.
- b. Timely correction of class and home assignments, test papers, projects etc.
- c. Setting of question papers for various tests and exams.
- d. Preparation of lesson plans and maintaining academic records of students.
- e. Preparing students for curricular/co-curricular activities, house activities, various cultural competitions etc.
- f. If required, escorting the students for activities outside the school.
- g. Performing invigilation duty/evaluation work as and when assigned.
- h. Any other work to be assigned by the principal.

**Terms and conditions:** - The candidates who would be selected as guest faculties shall work subject to the following terms and conditions:

- a. Guest faculty engaged would have no claim or right for appointment on regular basis nor will they be part of the cadre of teachers of Ekalavaya Model Residential School (EMRS).
- b. There shall not be any upper limit in taking number of classes.
- c. Guest faculty will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
- d. Working hours shall be same as other teachers.
- e. The engagement of the guest faculty teachers will automatically come to an end once a regular/contractual teacher is appointed/engaged against the vacant post in EMRS.
- f. The guest faculty so engaged shall also be entrusted with correction and evaluation work of the concerned subject in the EMRS and he/she will not be entitled for extra honorarium for such work.
- g. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non-performing or engaged in activities amounting to misconduct, he/she shall be

disengaged by the EMRS Principal under intimation to the District Welfare Officer/Secretary, OMTES.

- h. Maximum age for guest faculty at the time of application shall be sixty-two (62) and the retired teacher engaged as guest faculty under the scheme shall be disengaged on attaining the age of sixty-five (65).
- i. Unauthorised absence for a continuous period of 15 days or more, will automatically terminate her/his engagement.
