

3. **Date of receipt and mode of submission of tender papers:** - The bid documents shall be received through Registered Post /Speed Post only, and in no any other means, which must reach to the office of the B.D.O., Subdega, At/PO. -Subdega, Pin-770014, Dist.- Sundargarh (Odisha) by **05.30 PM on dated 14.02.2025**.
4. **Last Date of receipt of Tender Paper:** - The last date of receipt of tender paper is **14.02.2025** (upto 05.30 P.M.). The undersigned will not be responsible for postal delay if any or non-receipt of the paper in time. The tenderer must super scribe "**Tender Paper for Civil Works**"without mentioning the name of the work on the top of the cover.
5. **Date of Opening of Tender Paper:** - The tender papers will be opened on **15.02.2025** at 11.00 A.M. to till completion to next day in the presence of the tenderers or their authorized representatives in the office of the undersigned.
6. **Earnest money deposit:** - The E.M.D. is to be deposited in shape of N.S.C / Post Office Saving Bank Account / Post Office Time Deposit Account / Kisan Vikas Patra / Bank Guarantee in favour of **Block Development Officer, Subdega** from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar as per Office Memorandum No. 1499 dated 01.02.2023 of Works Department. The Tender Papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D. is also inadmissible. **Bidders may write an application to the undersigned for pledging of N.S.C. / Post Office Saving Bank Account / Post Office Time Deposit Account / Kisan Vikas Patra.**
7. **Documents to be attached:** - The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
 1. Tender paper cost in shape of DD in favour of the Block Development Officer, Subdega.
 2. Self-attested copy of Contractor Registration Certificate.
 3. Self-attested copy of PAN Card, GST Registration certificate.
8. SC/ST bidders are eligible for 50% EMD/ ISD exempted and 10% price preference without submitting any affidavit as per OPWD Code & Engineering / Physically Handicapped (PH) contractors should submit an undertaking in shape of an affidavit that he has not availed the concession of more than 3 times in the current financial year.
9. The civil contractor in order to take part in the composite tender should enter into an M.O.U. (Memorandum of Understanding duly notarized) with eligible registered electrical contractor having valid H.T. / L.T. license; for execution of electrical installation and other electrical works and a copy of such M.O.U. should be attached with the tender as per the proforma at Schedule- C which shall form a part of tender. A copy of electrical license should also be enclosed with the tender papers, the original of which need to be furnished during verification. The above M.O.U. is not required in case of the civil contractor having valid registration in H.T. / L.T. electrical license with the same name & style.
10. If any of the bidder quotes less than 15% of the tendered amount, than such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and the provision laid down in clause No.36 of Memorandum No. 1437, dated 31.01.2023 of Works Department. Govt. of Odisha will be followed.
11. **Additional Performance Security Deposit:** -


Additional Performance Security shall be deposited by the bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish.


The E.M.D. amount will be forfeited, if the tenderer breaks out from the offer acceptance of tender, by the competent authority.

13. Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
14. On review of the last performance of the work executed through B.D.O., Subdega, the lowest-1 tender may/ may not be considered for the works though he/she becomes lowest-1 tenderer.
15. Quality of works cannot be compromised and the work should be completed within the stipulated period of completion and in no case the time extension will be allowed except the reasons not attributable to contractors. The whole process of Tender will be evaluated /conducted as per Govt. guidelines and OPWD code. The Contractors who have failed to execute projects of this agency/broke out from execution process / abandoned the project work midway/those who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any of such contractors participates then his/her papers will not be considered at all.
16. **G.S.T. shall be paid extra as applicable.**
17. **The bid documents are to be submitted in sealed cover with tender paper cost, required amount of EMD & self-signed in each page of DTCN, BOQ, copy of valid registration certificate, PAN card, GSTIN, other documents (if attached) & original affidavit regarding authentication of documents for a particular work as mention in the tender notice, failing which the bid documents will be rejected.**
18. The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.
19. The contractor should have an Experience of execution in similar nature of works (e. building works including EI & PH work not less than 60% of estimated cost during previous five financial years from 2019-20 to 2023-24.




