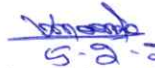

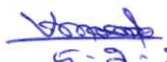

2. The Tender has been invited under two **bid systems i.e., Technical Bid and Financial Bid**. The interested Agencies are advised to submit two separate sealed envelopes super scribing "Technical Bid for printing & supply **packaging material for Take Home Ration (THR) MSPY**" and Financial Bid. Both sealed envelopes should be kept in a third sealed envelope super scribing "Tender for printing & supply **packaging material**". First the technical bids will be opened & subsequently the financial bids of successful bidders who have qualified in the technical bid process will be opened. All bids will be opened in the presence of the tender committee members and in the presence of bidders or their authorized representatives.
3. It is the responsibility of the bidders or their authorized representatives to remain present during the opening of bids.
4. The following documents must be covered in Technical Bid envelop, otherwise their bids shall be summarily/out rightly rejected and will not be considered any further action. Please refer(ANNEXURE-A)
 - a. Attested copy of GST certificate.
 - b. Attested copy of PAN
 - c. Attested copy of IT return of last financial year.

- d. Attested copy of the registration certificate under DIC/MSME/SSI or any valid Govt. Institution.
 - e. Cost of Tender paper Demand Draft (SBI) in favor of DSWO, Sundargarh amounting to 5000/- towards cost of paper (Non refundable).
 - f. Demand Draft (SBI) in favour of DSWO, Sundargarh for Rs.85,000/-(Rupee Eighty Five Thousand) only towards EMD(Refunded) or Valid document for EMD exemption.
 - g. Attested copy of the past performance certificate or work experience or work orders for similar kind of work.
 - h. Undertaking that the agency is not blacklisted by any Govt./PSU agency/Institution.

6. The tender papers can be downloaded from Sundargarh NIC website (<https://sundargarh.odisha.gov.in/>). The downloaded form filled in complete details must be submitted along with non-refundable D.D Rs.5000/- in favour of DSWO,Sundargarh.
7. The successful firm/agency will have to deposit 5% of total contract value as security deposit at the time of the agreement and it will be pledged in favor of DSWO, Sundargarh. If the firm fails to map the complete supply of the required materials as per the supply order the security deposit will be forfeited.
8. Penalty or legal action may be initiated for the agency deviating the terms and conditions laid down in the tender process. If during the field visit it is found that the agency has supplied sub-standard materials not adhering to the specification laid down in the tender document both in quantity and quality. Then strict action would be initiated against him/her as per the final decision of Collector, Sundargarh.
9. The agency must furnish an undertaking to adhere to the specification, content and quality for supply of packaging material undertaking that it is not blacklisted by Govt/PSU agency or institution (format Enclosed). If

- during the field visit it is found that there is deviation from required specification, quantity and quality, then the security deposit of the agency will be forfeited and further the agency will not claim any amount for packing materials supplied to 38no's SHGs.
10. Only the successful bidder who is selected to print & supply the packaging material to 38SHGs. The sample is for reference purpose only & it is to orient the bidder on content & size. If the bidder has not voluntarily collected the samples from DSWO Office, then it will be assumed that the bidder already understands the content, quality and detailed specifications of packaging material. The finally selected bidder will have to place 5nos of sample copies each of packaging material before the tender committee,
 11. Delivery will be made to 38 SHGs of Sundargarh District within 10 days from receipt of supply order from DSWO Office.
 12. The Maximum Packaging cost will be **Rs.1.50/kg** for SUW & MAM and **Rs. 2.00/kg** for PM/NM & AG, as per W&CD guidelines letter no- WCD-ICDS-N-SCHM-0028-2023/5299/WCD on dt. 04.03.2024 and letter no- WCD-ICDS-N-SCHM-0032-2023/3226/WCD on dt. 12.02.2024.
 13. The Fixed Design of Packaging material as per specified in (**ANNEXURE-C 1Nos to 8 Nos**)
 14. The Packaging material Specification for Take-Home-Ration under MSPY for PW&LM, AG and SUW & MAM Children as per mentioned **Annexure-D**.
 15. The selected Agency must deliver the packaging materials at 38 SHGs of Sundargarh District and the CDPOs will acknowledge on the receipt challans duly signed by the receiver SHG then the price of payment will be made.
 16. If the successful firm fails to execute the contract or withdraw the tender paper, the EMD of the firm will be forfeited. supply the same and the differential amount will be recovered from first tenderer (L1).

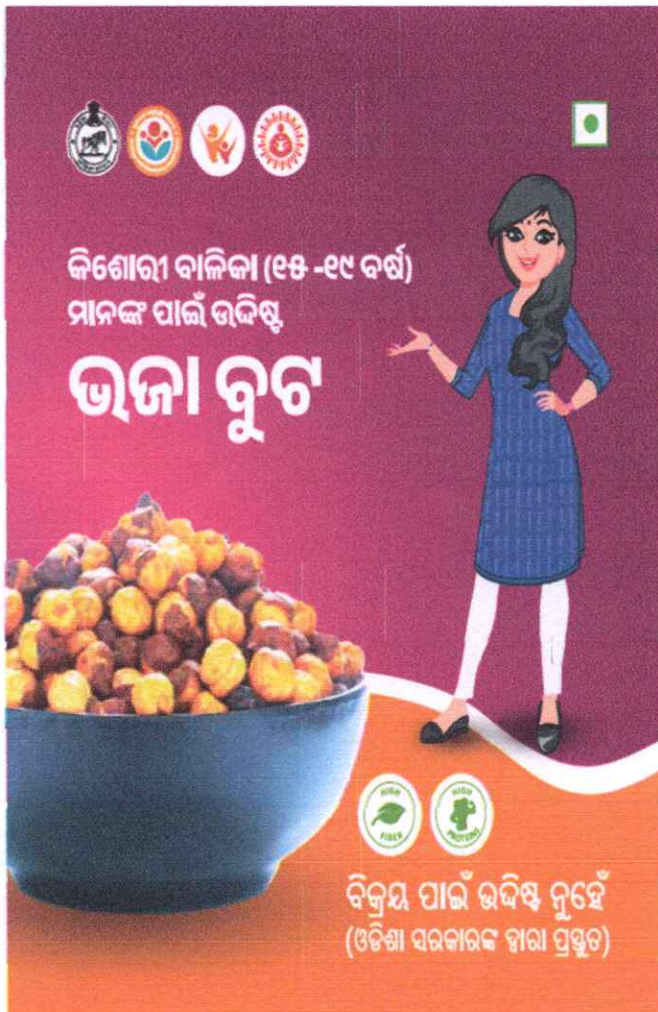

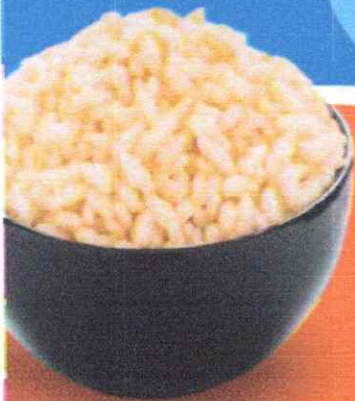

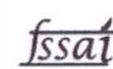
