Whereas the following Government land described in the Land Scheduled measuring an area of Ac. **150.582** dec. of Govt. land recorded under Abad Ajogya Anabadi Holding No. 83 of Village Bhograkachhar under Subdega Hemgir is required for allotment in favour of Chief Manager (Land), IDCO, Bhubaneswar for creation of Land Bank for Establishment of Industries & allied activities at village Bhograkachhar for an area of Ac. 150.582.

Accordingly, the Tehsildar, Hemgir to make necessary correction in the Record of Right in his Office.
