1. The Superintending Engineer, Rourkela Irrigation Division, Rourkela., Dist.–Sundargarh on behalf of Hon'ble Governor of Odisha invites on-line **Percentage Rate bids in single cover system** for the construction of work detailed in the table below from the **class of contractors** as mentioned in **Column-6** against each work registered with the State Governments and contractors of equivalent Grade / class registered with Central Government / MES/ Railways or other govt. undertakings for execution of Civil works. All the contractors are to be registered in the State portal and must possess compatible digital signature certificate of **Class-II and III** for on line bidding. The proof of registration from the appropriate authority shall be enclosed along with the bid. The website for online bidding is <http://tendersorissa.gov.in>.

2. Bid document consisting of information, specification and bill of quantities of the works are available in web-site www.tendersorissa.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and submission of Bid.
3. Government of Odisha has mandated online registration of all categories of contractors in CDMS portal (www.cdmsodisha.gov.in) vide O.M. No. 12934 dt.23.08.2018 of Works Department and Works Department Letter No. 9100 dated 17.07.2020. As per the codal provision vide clause No. 12.4 of Appendix IX (A) of O.P.W.D. code Vol. (II) all classes of contractors are requested to register themselves in CDMS Portal. Tender Inviting Authority will not accept any tender if contractors are not registered under CDMS portal & their tenders will be rejected.
4. As per works Department, Government of Odisha, Office Memorandum No 07554600032022(File No.) - 1499/01.02.2023, Security for the due fulfilment of a contract for the specified work should be submitted in shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra/ Bank Guarantee in favour of the Superintending Engineer, Rourkela Irrigation Division, At / Po-Panposh, Rourkela - 4, Dist.-Sundargarh from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch / e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal towards E.M.D/initial Security Deposit/ any other security deposit from the contactor or supplier as mentioned in column 05 of the above table.
5. No Cheque / Bank Draft / Cash Payment will be accepted towards EMD.
6. Adjustment of earnest money given with other tenders previously and submitted in other tenders shall not be entertained.

The Bidder shall transfer online the cost of Bid document (Non-refundable) amount specified for the works in the table Col-06 above per set towards cost of the bid through process as mentioned in the DTCN vide Office Memorandum No. 17254/W/dated 05.12.2017 of Works Department, Govt. of Odisha.

8. The bid is to be submitted through the e-procurement portal with documents such as scanned copies of GST Registration Certificate, valid Registration certificate, PAN card, Affidavit, No Relation Certificate (N.R.C.) and documents required as per the relevant clauses of DTCN with Bill of Quantity (Financial Bid). Non-submission of required documents, the bid will be treated as non-responsive.
9. The bidders shall prepare the documents and upload the scanned typed document in PDF format and BOQ in excel format (or as specified in the portal) in appropriate place.
10. The bidder can resubmit his bid through online e-procurement mode out of which the system shall consider only the last bid submitted to the portal.

N.B. In the event of the specified date of bid opening being declared as a holiday the officer inviting the Bid, the bids will be opened at the appointed time on the next working day.

12. Bid validity period of the tender is for a period of 90 days from the last date of submission of Bid. If any bidder withdraws his bid before the said period or makes any modification in the terms and condition of the bid, she/he will be suspended for 3 (Three) years.
13. Exemption of EMD to the Engineer Contractor will be allowed for a maximum of three (03) works in a financial year and the fact of the awarding a work with exemption of EMD should be entered in the original registration certificate of the Engineer Contractor. Engineer Contractor desires to avail the exemption of EMD is required to submit an affidavit to the effect that He / She has not availed the facility for more than two works during the current financial year and that all works for which EMD exemption availed has been entered in the original registration certificate. (as per works Department Letter No 6315 dt.16.06.2011).
14. SC/ST contractor desires of availing benefit as per Works Department Resolution No. 16262 dated 30.10.2018 must submit affidavit for the same falling which the contractor will not get the price preference.
15. No Engineer of Gazetted rank of other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor till a period of two years after his/her retirement from Government Service without Government permission.
16. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
17. The bidders shall have to produce an Affidavit in support of authenticity of documents like credential, GSTIN Certificate, Registration Certificate, PAN Card including the E.M.D accompanying the bid. The authority reserves the right to verify the authenticity of document in case any doubt or complain arises. GST on works contract as applicable at the time of payments shall be paid extra over the gross amount.

18. The original **affidavit** should be retained by the bidder with him. The bidders have to furnish the original documents to the Superintending Engineer, Rourkela Irrigation Division, Rourkela as and when demanded for verification of tender. The successful bidders have to submit the original affidavit to the Superintending Engineer, Rourkela Irrigation Division, Rourkela before drawl of Agreement.

19. If the rate quoted by the bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted (decimal up to two numbers will be taken for all practical purpose) either at estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a transparent lottery system in the **Office Chamber of the Superintending Engineer, Rourkela Irrigation Division, Rourkela** where all bidders/ their authorized representatives, the concerned SE/ Executive Engineer of Concerned Division and DAO will remain present. (O.M No- 0755960019022(file no)-1437 dt.31.01.2023 of works dept Govt of odisha).

N.B. In the event of the specified date for drawal of lottery being declared a holiday for the officer inviting Bid, lottery will be drawn at the appointed time on the next working day

20. In percentage rate tender, the bidder will quote percentage excess/less up to two decimal point only. If he writes the percentage excess/less up to three or more decimal points, the second decimal point shall only be considered without rounding off (vide Works Department O.M No- 7885 dtd. 23.07.2013).

21. **Additional performance security APS (As per works Dept. O.M No- 4559/dt 05.04.2021)** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the Additional performance security as per the following rate:

The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of Term Deposit Receipt pledged in favour of Superintending Engineer, Rourkela Irrigation Division, Rourkela / Bank Guarantee in favour of Superintending Engineer, Rourkela Irrigation Division, Rourkela from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch within **seven days of issue of Letter of Acceptance (LOA)** by the Superintending Engineer, Rourkela Irrigation Division, Rourkela (by e-mail) to the successful bidder, otherwise his/ her bid shall be cancelled and Earnest Money Deposit / Bid Security shall be forfeited. Further, proceeding for Blacklisting shall be initiated against the bidder as per amendment to Para 3.5.5 (v) of OPWD Code, Volume-I vide **works Department office Memorandum No.14459/W dated 20.09 2018.**

22. Amendment to Para 3.5.18. of OPWD code vol-I & rule-29 of Appendix-IX of OPWD code Vol-II "The single tender received in 1st call shall be cancelled without opening of the bid & fresh tender will be invited" as per Office Memorandum No. 16 dated. 01.01.2015 of Works Department Govt. of Odisha and as per "Works Department O.M. No. 16, dated. 01.01.2015 implies that single tender received in the first call shall be cancelled without opening of bid and in case when more than one tenderer have been received in the first call and only a single tender is found to be responsive, the same is also liable to be cancelled due to lack of competitive price bidding. (Vide Letter No. 4410 dt. 19.02.2018 of DoWR & Memo No. 4714 dt. 13.02.2018 of the E.I.C., W.R., Bhubaneswar.

23. The successful bidder shall submit original affidavit, EMD along with other documents in original for verification during drawl of agreement.

24. Agreement shall be drawn only after due verification of ISD & APS of the successful bidder. If any fake documents are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for black listing through the license issuing authority.
25. If the 1st lowest bidder does not turn up for agreement after finalization of tender, than he/she shall be debarred from participation in bidding for three years & action will be taken to black list the contractor as per codal provision in Appendix-IX (A) of OPWD-Vol.-II regarding e-procurement vide **Office Memorandum No.7885/W Dated 23.07.2013 clause No.22.3.**
26. Any tenderer desirous to avail any facility as per certain circular / order of Govt. have to apply for the same in writing and has to furnish scanned copy of the application with copy of circular along with the tender paper in portal, failing which request at later stage will not be considered.
27. Schedule Caste and Schedule Tribe tenderers will be given concession where their tenders are within 10% of the rate quoted by the lowest tenderer for any work. The work may be considered for award to him / them at the lowest tendered rate in relaxation of rule 18 of O.G.F.R. Vol. I & Para 3.5.14 of O.P.W.D. Code vide Govt. of Odisha Works Deptt. Circular No.27748 dated 11.10.1977.
28. All revised Rule, Regulations, Govt. Circulars will be abided as per OPWD Code.
29. As Goods and Service Tax has come into force with effect from **01.07.2017**, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act-2017. Goods and Service Tax (GST) shall be applied as per prevailing rules or as amended from time to time.
30. The bidder should mention his detail address and **Phone no. & e-mail ID** in the separate sheet for communication regarding the tender.
31. The On-Line bidder shall digitally sign on all statement, documents certification uploaded by him owning responsibility for their correctness/authenticity as per IT act 2000. If any of the information is found to be false/fabricated/bogus, his/her EMD/BID security shall stand forfeited and his/her registration in the portal shall be blocked and bidder is liable to be blacklisted.
32. Any corrigendum / Addendum will be displayed in the website www.tendersodisha.gov.in only.
33. The authority will not be held responsible for any technical problem / failure of Network, Server during the schedule dates of online bidding.
34. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
