2. The tender paper will be available in the District website of Sundargarh (www.sundargarh.odisha.gov.in) from date 09-07-2025 to 19-07-2025 up to 5.30 PM.

The bid shall be received through Registered post/ Speed post only, and in no any means, which must have reached to the office of the Chief District Medical & Public Health Officer, Sundargarh by **5.30 PM on dated 22-07-2025**. In the address of "Office of the Chief District Medical & Public Health Officer, DHH, Sundargarh, Odisha, PIN 770001". Further the bid must be received be on or before stipulated date and time as mentioned. The authority will not be responsible for the postal loss/ delay or for any other reason. The bid received beyond the deadline (after 22-07-2025, 5.30 PM) will not taken into consideration for opening & should be rejected accordingly. The tender papers shall have to be submitted into a sealed cover for each work separately super scribe with "TENDER PAPER FOR NHM CIVIL WORK" without mentioning the name of the work on the top of the cover. The bid will be opened on dated **23-07-2025 at 11.30 AM** in the Conference Hall of the Chief District Medical & Public Health Officer, Sundargarh.

4. The cost of the bid documents should be prepared in shape of Demand Draft issue from any Nationalised Bank in favour of **ZSS, NON-NRHM, A/C Sundargarh** payable at Sundargarh for each bid separately. The cost of the tender paper is non-refundable. Similarly, the cost of the bid security (EMD@1%) required in shape of TDR of FDR/ Bank Guarantee any Nationalised/ Schedule Bank in India counter guarantee by its local branch at Bhubaneswar, National Saving Certificate (NSC)/ Postal term deposit duly pleased in favour of **ZSS, NON-NRHM, A/c Sundargarh**, at the time of bidding of tender as per the office memorandum no 8484 date 05.04.2022 of Finance Department, & 1499 date 01.02.2023 (NSC/POTD) Works Department, Govt. of Odisha.

The bid documents are to be submitted in seal cover with tender paper cost, required amount of (EMD 1%), self attested in each page of DTCN, BOQ, copy of valid registration certificate, PAN, GSTIN, other documents (if any) related to tender & original affidavit regarding authentication of documents for a particular work as mention in the tender notice, failing which the bid documents will be rejected.

6. SC/ ST contractor should submit a claim application (affidavit) in this regard & engineering contractor should submit an undertaking in shape of affidavit that he/ she has not availed the concession of more than 3 times in the current financial year.



8. The bidder should submit the Bill Of Quantity (BOQ) along with Detailed Tender Call Notice (DTCN) & the related documents for each work separately.

2. The authority reserves the right to reject any or all the tenders without any reasons thereof.




