6. Bid shall be received only on **"On Line"** mode on or before **5.00 P.M. of dated: - 15.12.2025.**
7. Bid received on line shall be **opened** at 11.30 A.M on **dated - 16.12.2025** in the Office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the Office happens to be closed on the date of the opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The scan copies of GST, ITCC (PAN CARD), Contractor license, affidavit regarding EMD concession/exemption, no-relation certificate, tool and plants, signed copies of terms and conditions for the particular work should be submitted online.
9. The successful bidder shall have to deposit the **less** amount as Additional Performance Security (APS) in shape of DD/TDR pledged in favour of the Executive Officer, Birmitrapur Municipality as per works Department office memorandum No. 4559, date 05.04.2021.
10. Any bidders desirous to avail any facility as per certain circular/order of Government have to apply for the same in the affidavit along with copy of the circular/order.
