Limited sealed quotations are hereby invited from local transport agencies/firms (preferably) for transportation of Non-Recyclable Dry Waste from the Material Recovery Facility (MRF) Centre, Rajgangpur Municipality to the designated cement factory for co-processing, as & when required.

Scope of Work

- ❖ Collection of non-recyclable dry waste from the MRF Centre, Ward No.10, Henjatoli.
- ❖ Transportation of the collected waste to Dalmia Cement Bharat Ltd., Rajgangpur Cement Factory, as directed by the Municipality.
- ❖ Safe handling, loading, unloading, and timely delivery of waste.
- ❖ Vehicles deployed must comply with all statutory and safety requirements.

Eligibility Criteria

- ❖ Valid GST Registration Certificate
- ❖ PAN Card
- ❖ Vehicle Registration, Fitness Certificate & Pollution under Control (PUC) Certificate
- ❖ Experience in transportation of waste/similar materials (if any)

Tender Paper Cost & Earnest Money Deposit (EMD)

- ❖ **Tender Paper Cost:** Tender Paper Cost of Rs. 6,000/- shall be submitted along with the quotation in the form of Demand Draft drawn in favour of Executive Officer, Rajgangpur Municipality, payable at Rajgangpur.
- ❖ **Earnest Money Deposit (EMD):** Each bidder shall submit an EMD of Rs. 20,000/- (Rupees Twenty Thousand only) in the form of Demand Draft / Bank Guarantee drawn in favour of Executive Officer, Rajgangpur Municipality, payable at Rajgangpur.

Quotations without Tender Paper Cost and EMD shall be summarily rejected. The EMD of unsuccessful bidders shall be refunded after finalization of the quotation process, whereas the EMD of the selected bidder shall be retained and adjusted towards Security Deposit (if applicable).

Interested local agencies/firms may submit their quotation along with all required documents, complete in all respects including all annexures attached, shall be submitted in a duly sealed envelope, superscribed with the words "*Limited Quotation for Transportation of Non-Recyclable Dry Waste*", and addressed to the Executive Officer, Rajgangpur Municipality, so as to reach the undersigned on or before 1.00 P.M. of Dt.07.01.2026 through Speed Post / Registered Post / Courier / By hand. The quotations so received shall be opened on the same day at 04:00 P.M. in the chamber of the undersigned. Applications received after the due date and time shall be summarily rejected, and Rajgangpur Municipality shall not be responsible for any delay in postal or courier delivery.


Terms & Conditions

The selected agencies/firms shall provide services for a period of 12 (Twelve) months from the date of finalization / issue of intimation to the agencies/firms selected in the process.




