3. Bids must be submitted on "online" on or before **16.12.2025** by 17.00 hours.
4. Bids shall be opened 11.00 hours on **18.12.2025** in the office of the undersigned in the presence of the bidders or their Authorized agents who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working days at the same time and venue.
5. The Bid document shall contain scan copy of (a) Registration certificate, (b) PAN, (c) GST Registration in details (full copy ) other document required as per DTCN and special condition if any.

6. Rate quoted by the Contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST on the gross amount of bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule.
7. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
8. Non submission of online bid security within the designated period shall debar the bidder from participating in the on-line bidding system and his portal registration shall be blocked. His name shall also be informed to the registering authority for cancellation of his registration as Contractor. VII. Contractor exempted from payment of EMD will be able to participate in the tender directly by uploading documentary evidences towards his eligibility for such exemption.


