This is with reference to the EOI for "Empanelment of PSUs for various Infrastructural works of different values under DMF, Sundargarh" issued vide EOI No. DMF/02/2025-26 dated 02.03.2026.

3.	Cl. No. 5. Execution of Infrastructural Works/ Projects:	6	In the event of acceptance of the Application, the execution of infrastructural works/ projects for DMF, Sundargarh shall be rendered with respect to the terms and conditions as stipulated in the Public Works Dept (CPWD/ OPWD) Code in conformity with the Contract/ MoU. The applicants shall have to quote the Project Management Consultancy (PMC) Charges in percentage (%) of the Project Cost (Excluding Taxes applicable thereto) on prescribed format already provided in the RFP. This PMC charges amount shall be exclusive of all the applicable taxes as per GST Act. The rate offered remains fixed for the whole contract period or for the extended agreed period.	In the event of acceptance of the Application, the execution of infrastructural works/ projects for DMF, Sundargarh shall be rendered with respect to the terms and conditions as stipulated in the Public Works Dept (CPWD/ OPWD) Code in conformity with the Contract/ MoU. The applicants shall have to execute the work as per the least quoted PMC charges of empanelled PSU(s). The rate fixed after the empanelment remains fixed for the whole contract period and/or for the extended agreed period.

Other terms and conditions of the EOI remain the same.
