The Block Development Officer, BARGAON, Sundargarh on behalf of Governor of Odisha invites in “**ONLINE MODE Percentage Rate bids (Single Cover)**” for the following work from the class of eligible contractors as mentioned in Column-4 (four) registered with the State Governments having validity of Civil License and contractors of equivalent Grades/Class Registered with Central Government/ MES/ Railways and other state government having validity of Civil License for execution of Building Works (including EI & PH). The proof of registration from the appropriate authority shall be enclosed along with the Bid. The eligible contractors of the state P.W.D. (R&B)/ Water Resources/Rural Works/M.I./C.P.W.D. for the following work eventually to be drawn up in the P.W.D. P1 forms in conformity with the Detailed Tender Call Notice. The bidders may submit bids for the following work.

1. Bid documents will be available in website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **25.05.2026** to **05.06.2026** for online bidding. The bidders must possess compatible Digital Signature Certificate of Class-II or Class-III
2. Tender Paper cost and EMD for the above work will be realized through e-procurement Portal by uploading proof of payment in pdf format. Please note that Off line payment of Paper cost or EMD amount in original will be accepted in opening day.
3. Bids must be submitted on “online” on or before **05.06.2026** by **17.00** hours.
4. Bids shall be opened at **09.00** hours on **06.06.2026** in the office of the undersigned in the presence of the bidders or their Authorized agents who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, The bids will be received and opened on the next working days at the same time and venue.

5. The Bid document shall contain scan copy of (a) Registration certificate, (b) PAN, (c) **GST Registration in details** (full copy ) other document required as per DTCN and special condition if any.
6. Rate quoted by the contractor shall be excluding GST. The GST as applicable for the work contractor shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST on the gross amount of bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule.
7. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
8. **The MSME is not be applicable to procurement of services including work contracts (including EPC Contracts) vide MSME Department Notification No. MSME-IPE-MISC-0060-2019/566/MSME, Bhubaneswar, Dated. 24.01.2024.**
9. As per provision under OPWD Code e-Tendering chapter under clause no.14 (vi) the Procurement officer-publisher (undersigned) shall not be responsible for or non receipt of ONLINE Tender paper cost, bid security on or before specified date and time. Non submission of online bid security within the designated period shall debar the bidder from participating in the on-line bidding system and his portal registration shall be blocked. His name shall also be informed to the registering authority for cancellation of his registration as Contractor. (VII). Contractor exempted from payment of EMD will be able to participate in the tender directly by uploading documentary evidences towards his eligibility for such exemption.
10. SC/ST bidders are eligible for 50% EMD / ISD exempted and 10% price preference without submitting any affidavit as per OPWD Code & Engineering / Physically Handicapped (PH) contractors should submit an undertaking in shape of an affidavit that he has not availed the concession of more than 3 times in the current financial year.
11. The civil contractor in order to take part in the composite tender should enter into an M.O.U. (Memorandum of Understanding duly notarized) with eligible registered electrical contractor having valid H.T. / L.T. license; for execution of electrical installation and other electrical works and the original affidavit of M.O.U. should be attached with the tender as per the proforma at Schedule- C (Each work separately) which shall form a part of tender. A copy of electrical license should also be enclosed with the tender papers, the original of which need to be furnished during verification. The above M.O.U. is not required in case of the civil contractor having valid registration in H.T. / L.T. electrical license with the same name & style.
12. **Additional Performance Security Deposit: -**  
Additional Performance Security shall be deposited by the bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish.

14. Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
15. On review of the last performance of the work executed through B.D.O., BARGAON, the lowest-1 tender may/ may not be considered for the works though he/she becomes lowest-1 tenderer.
16. Quality of works cannot be compromised and the work should be completed within the stipulated period of completion and in no case the time extension will be allowed except the reasons not attributable to contractors. The whole process of Tender will be evaluated /conducted as per Govt. guidelines and OPWD code.
17. The Contractors who have failed to execute projects of this agency/broke out from execution process / abandoned the project work midway/those who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any of such contractors participates then his/her papers will not be considered at all.
18. If after opening of the tender, it is seen that the bid amount will be same then lottery will be held in the same date in present of tenderer or their authorized representatives.
19. The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.




