

1. Bid Documents consisting of Plans, Specifications, Schedule of Quantities and the Set of Terms and Conditions of Contract and other necessary documents can be seen in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in)
2. The Bid for the work having cost 50 lakh & above are invited through double cover system (Technical & Financial) refer DTCN for details.
3. The bidders must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
4. The Authority will not be held responsible for any technical snag or network failure during online bidding.
5. The Cost of Bid Documents and initial bid security to be deposited on electronically transfer system as per provision of e-tender.
6. The Bidder may ask questions in the e-procurement portal using his/her DSC from Dt. **09.06.2026** at 10.00 AM to Dt. **23.06.2026** up to 5.30 PM.
7. Subsequent corrigendum/addendum if required shall only be available in web site indicated above.
8. Scanned clear copies should be uploaded. Non-visible copies of documents may be liable for rejection.
9. The Amendments made vide Works Dept. Memorandum No.12366 Dated. 8.11.2013 will be followed scrupulously.
10. General Instructions to Contractors issued vide Lr. No 20415/DOWR Dt14.09.2015 will be adhered strictly.

12. Works will be taken up as per the availability of Funds.
13. After careful observation, Government has been pleased to abolish the extant provisions of threshold negative bid caps of 15% introduced vide Works Department OM No.12366/W dt. 08.11.2013 and amended vide Works Department OM No. 1437 dt. 31.01.2023 in Appendix-IX, Clause 36 of OPWD code Volume-II in the procurement of works undertaken by the Govt. of Odisha and its agencies to ensure the procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system.
14. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. The successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional Performance Security at following rate as per O.M.No.173 Dated. 03.01.2026 of works Department Govt. of Odisha.


The Additional Performance Security (APS) shall have to furnish in shape of N.S.C/Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikash Patra/ Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by

its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal within seven days of issue of letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, processing for blacklisting shall be initiated against the bidder.

15. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
16. **If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes), either at the estimated cost put to tender or less than the estimated cost put to tender**, the tender accepting authority will finalize the tender through a transparent lottery system, where all the concerned bidders/their authorized representatives, the concerned Superintending Engineer and Divisional Accountant Officer (DAO) will remain present as per Works Department Memorandum No. 632 dated 09.01.2026.
17. If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para 2 of Works Department Resolution No. 27748 dated 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.
18. The contractor should have registered his/her name in **Contractors Database Management System (CDMS)** irrespective of tender amount in concurrence to Letter No.30613, dt.22.07.2019 of Engineer-in-Chief (Civil), Odisha, Bhubaneswar. Non registration in CDMS portal is liable for rejection of the tender.
19. The amount quoted by bidders shall remain **valid for 90 (ninety) days** from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & conditions of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his/her registration as contractor including forfeiture of bid security deposited.
20. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
21. The Tender will be opened on the next working day if the Date of Opening happens to be holiday.
22. Engineering contractors desirous to avail EMD exemption have to submit affidavit with uploading the same in e-portal tender declaring therein to the effect that they have not yet availed **3 (three) nos.** of EMD exemption during the financial year **2026-27**, else his/her tender may be rejected and to show the original Registration Certificate to the tender opening authority for confirmation at the time of opening.
23. Affidavit regarding authenticity of document and affidavit to avail price preference in case of SC/ST contractor, should be uploaded for each work separately, else his/her tender may be rejected.
24. This Notice is to be read with all clauses / addendum to the 'Procedure to participate in on-line Biddings'.
25. If any intending bidders wish to withdraw from participation in the bid, He/ She can freely withdraw from the participation before scheduled date and time of closure, in case the 1<sup>st</sup> lowest bidder & next lowest bidder withdraw after opening of the bid, they shall be penalized with adequate disincentives with forfeiture of EMD/ Bid security unless adequate justification for such back out is furnished. Appropriate action for blacklisting the bidder shall also be taken apart from disincentivizing the bidder.
26. **GST to be imposed as per Govt. guidelines from time to time.**
27. **Valid GSTIN certificate should be uploaded else his/her tender may be rejected.**
28. **The bid documents should be uploaded by the bidder accompanying copies of E.M.D, valid contractor Registration Certificate, valid GSTIN Certificate, PAN Card, Cost of tender papers,**

No Relation Certificate & Affidavit about the authenticity of the tender documents for each work separately else the bid will liable for rejection.


- 29. The preferences/Relaxations granted to local Micro & Small Enterprises (MSEs) and Startups in the procurement of works, as per Works OM No. 503/W dated 17.01.2022 have been withdrawn. Effective from the date of Works OM No. 4281/W dated 05.03.2025, these relaxations will no longer be acceptable.
- 30. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and incase of failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
- 31. Quality control tests as per specification for all items of the work executed will be taken up in nearby Government Quality Control Laboratories of Minor / Medium / Major Irrigation Organization. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respects at his own cost.
- 32. Penalty will be imposed as per agreement condition if the work is not completed within the stipulated period or the progress of work is not as per the work programme.
- 33. Authority reserves the rights to reject any or all the tenders without assigning any reason thereof.




