The authority will not be responsible for the postal loss/ delay or for any other reason. The bid received beyond the deadline (after 10-06-2026, 5.30 PM) will not taken into consideration for opening & should be rejected accordingly. The tender papers shall have to be submitted into a sealed cover for each work separately super scribe with "TENDER PAPER FOR NHM CIVIL WORK" without mentioning the name of the work on the top of the cover. The bid will be opened on dated 11-06-2026 at 11.00 AM in the Conference Hall of the Additional District Urban Public Health Officer, Rourkela.

4. The cost of the bid documents should be prepared in shape of Demand Draft issue from any Nationalised Bank in favour of NON-NRHM,A/C CHS ROURKELA payable at Rourkela for each bid separately. The cost of the tender paper is non-refundable. Similarly, the cost of the bid security (EMD@1%) required in shape of TDR of FDR/ Bank Guarantee any Nationalised Schedule Bank in India, National Saving Certificate (NSC)/ Postal term deposit duly pleased in favour of NON-NRHM,A/C CHS ROURKELA at the time of bidding of tender as per the office memorandum no 8484 date 05.04.2022 of Finance Department, & 1499 date 01.02.2023 (NSC/POTD) Works Department, Govt. of Odisha.

6. SC/ ST contractor should submit a claim application (affidavit) in this regard & engineering contractor should submit an undertaking in shape of affidavit that he/ she has not availed the concession of more than 3 times in the current financial year.

Additional performance security cost in shape of FDR or TDR/ Bank Guarantee in any nationalized Bank/ Schedule Bank, NSC/ Postal Saving Bank account/ Postal term deposit/ Kisan Bikash Patra duly pleased in favour of NON-NRHM,A/C CHS ROURKELA Sundargarh, at the time of agreement as per the office memorandum no 173, dated 03.01.2026 of works Department, Govt. of Odisha.

8. The bidder should submit the Bill Of Quantity (BOQ) along with Detailed Tender Call Notice (DTCN) & the related documents for each work separately.
